Annual Report on General Plan Indicates That 1151 New Housing Units Could Be on the Way.

his Thursday, February 20, 2014, the Planning Commission will hold a regular meeting. There will be one routine item on the agenda, which is the consideration of to an addition to a waterfront house on Dolphin Lane in Neighborhood 3 that is currently two stories. After that, the Commission will review the annual report on the City's General Plan.

California law requires that the legislative body of each city receive an annual report on the status of the General Plan and its implementation. The Annual Report is then forwarded to the California Office of Planning and Research and the Department of Housing and Community Development. The Government Code includes specific requirements for information about the status of housing element programs and progress in meeting the Regional Housing Need Allocations issued by the Association of Bay Area Governments (ABAG).

In her report to the Planning Commission, Consulting Planner, Leslie Carmichael has identified 17 highlights of the accomplishments made while implementing the General Plan in 2013. The report mentions that there are currently up to 1151 new housing units that have either been completed, are in the works, or that could be built. These units are located in either the various phases of the Pilgrim - Triton projects (730) or in the development of Foster Square, the 15 acre site (421).

The 17 items in the report include: 1) an update of the Land Use and Circulation Element, bringing the Goals, Policies and Programs up to date to align with the City's population and employment projections, concluded on page 2

- Application ' must include 25 signatures from residents of Foster City supporting the nominee's nomination
- A spokesperson must present nominee's qualifications (3-5 minute presentation) to a public meeting of the ad hoc committee and, if the candidate is selected, to the City Council.
- Applicants must submit a 5" x 7" photograph of the candidate for a Wall of Fame photo archive.
- Candidate cannot be currently employed by the City of Foster City.

The Quality of a Human Life

oster City has a reputation for offering an exemplary quality of life that is the envy of the Peninsula. We enjoy a healthy capital reserve and through the prudent management by past City Councils and Staff we maintain several healthy funds dedicated to Capital Improvements. This allows the City to maintain its infrastructure and to make necessary replacements and improvements when needed in a timely fashion to both the roadways and park systems.

I am proud to say that our Foster City staff, police and fire departments are among the best in the county. They provide quality service in a timely fashion and are easily accessible to our residents. Foster City is not only a great place to live, but a fantastic place to work. The experience of this is often referred to as "quality of life". I along with others am proud of the quality of life that we as a City have created and provide our residents. However, I grow increasing concerned with the balancing of competing interests with regard to the quality of a human life. Our quality of life in the City has deteriorated due to the traffic safety issues our residents are forced to experience as they go about their daily activities.

Over the past months our City and surrounding communities have experienced an increasing number of vehicles versus pedestrian fatalities and incidents. This has brought an important issue into the forefront of discussion. Do we as a community do enough to provide our citizens with safe passage as they go about their daily lives?

Foster City prides itself on being a neighborhood based community. citizen is far from a local shopping center, school or park or place of worship. In fact the community was designed so that residents could walk or bike to the aforementioned locations. However, it is important to note our City is over 40 years old and has grown to over 30, 000 residents and increasing number of daily commuters inside and outside our City. The increased need to maintain the flow of traffic per its demand has yielded increasing speed limits and lesser numbers of traffic signals and stop signs.

There is no doubt that the nature and tenor of drivers and pedestrians has changed over the years. "Distracted driving" due to talking on the phone, % f(x) = 0texting, etc. has led to an increasing number of careless accidents in which the pedestrian is always the loser. While I am a proponent of personal responsibility, I place a greater responsibility as does



and modernizing the language in the background and introductory text. 2) Elements of the "Sustainable Foster City: a Sustainable Economic Development Strategic Plan" moved forward, including a commercial market analysis of Foster City; 3) A Climate Action Plan was drafted for review in 2014. 4) Triton Plaza, including 307 units (20% affordable units) and 10,000 sq. ft. retail was completed and occupied; 5) Construction started for Triton Pointe including 166 units (20% affordable units) and 6,000 sq. ft. of retail; 6) Entitlements were processed for The Waverly including 240 units (20% affordable units) and 5,000 sq. ft. of retail; 7) Gilead completed construction of the lab building at 368 Lakeside Drive and is currently under construction of another lab building and pilot lab at 355 Lakeside Drive. Gilead received Use Permit approval to construct a parking garage on the South Campus and is in the entitlement process for a 10-story office building and 6-story parking garage on the North Campus. the State of California on the rights of a pedestrian to be afforded safe passage on our streets. My premise is simple. A vehicle is a material object that can be repaired or replaced when it is damaged. There is virtually no lasting effect on the machine. However the same cannot be said of a person. A person struck by a car will have life altering consequences that will manifest itself both physically and mentally. These often times cannot be repaired or improved. The physical effects of such an accident will be carried by that individual for the rest of their lives. This is not to diminish the effects on a driver's mental state who strikes a pedestrian. I understand the gravity and burden of the same.

As part of a Sustainable Foster City, "smart" options for walking and biking will be made part of the discussion. We will be faced with determining where and how the walkways and bikeways are governed. In doing so, we will have to ask ourselves what we value more and what policies do we wish to put in place to make the capital improvements necessary to support the safe passage of our community as we encourage individuals to get out of their cars and find alternate means of transport. Greater safeguard and focus will be needed. The question we as a City must ask ourselves is whether we value faster speed limits and lesser traffic signals more than we value human quality of life? Is it more important to us as a City to allow our residents to travel at 35 or 45 miles an hour past apartment complexes and

residence? Should we allow cars to travel unimpeded at these speeds at intersections where children cross to attend churches, schools and sporting activities?

Make no mistake. Foster City is a neighborhood community where our children walk, play, run and bike alongside cars travelling in excess of 40 miles an hour. In other communities they have 25 miles per hour speed limits because they value the future quality of life of their residents. At a recent council meeting a resident shared 4 stories about residents who were struck by cars on Edgewater Blvd. These residents still live and work in our community. In two cases, as a result of the seriousness of their injuries, they were air lifted to Stanford Hospital.

We are without question one of the safest cities in the country in which to live. But are we doing "enough" or can we do "more"?

I have heard the voices of our residents loud and clear. In fact, I have not heard a single voice that spoke in opposition to greater safety measures. Perhaps we should look at it as "enhancing" the measures we already take. For me, I will always err on the side of the safety of our residents versus the convenience of our vehicular traffic. Slower speed limits, more traffic signals or stop signs will increase the average commute time by 1 to 5 minutes within our City limits. I leave you with one last question. Is the value of one human life worth 5 minutes per day? I pose it as I believe our residents concur.



9-11 Sea Lift – Waterfront History- An Untold Tale



Anyone volunteer for Disaster Relief for the American Red Cross, I've had some pretty amazing experiences and last Monday night was no exception.

At the monthly Red Cross San Mateo meeting attendees Chapter were privileged to hear Captain Mike Day of the United States Coast Guard speak of his coordination of the massive evacuation of Lower Manhattan on 9/11, the day the twin towers fell.

As you know, New York's Manhattan is an island. When the towers were hit by airplanes and ultimately collapsed, the powers that be closed all access on and off the island. Subways stopped running and bridges and tunnels were closed. People in lower Manhattan, where the twin towers once stood, were in a state of fear and chaos. Emergency communications were cut off, because the first tower to fall was also home to the large antennas used by the police, fire and Coast Guard to communicate with one another.

People panicked and didn't know where to run. Hundreds of thousands ran to the water's edge in an effort to escape the choking dust cloud and to look for a way to get off the island, only to realize they were trapped.

Many jumped into the water and tried to swim away. Hundreds of others swarmed the limited number of available ferries and tug boats in a frantic effort to save their lives.

Captain Day soon realized that the only way in or out of Manhattan was via boat. He got on his marine radio and uttered these simple words, "All available boats, this is the United States Coast Guard.

to help with the evacuation of Lower Manhattan, report to Governor's Island." What he didn't know at the time was that this call triggered the largest sea evacuation in history. Within minutes,

boats of all sizes converged on Lower Manhattan. The larger boats were given a route to follow, for example, back and forth to Staten Island or back and forth to Hoboken, NJ. The

wanting

smaller, faster boats were used as sea ambulances, transporting those with relatively minor injuries to hospitals in the neighboring cities and islands. The thinking behind this was to free up the Manhattan hospitals to accept the mass casualties they thought would soon inundate them.

In less than 9 hours, the volunteer boat brigade evacuated nearly 500,000 people. Compare that to the Miracle of Dunkirk in WWII, where slightly more than 338,000 soldiers were evacuated over 9 days.

This little known story is the subject of an 11 1/2 minute video on YouTube, narrated by Tom Hanks, which you can see by going to http://www.youtube. com/watch?v=18lsxFcDrjo . It's titled BOATLIFT – An Untold Tale of 9/11 Resilience. An hour long documentary about the evacuation is currently in the works.

Mavericks Trail Repairs & Improvements

he San Mateo County Harbor District maintains a scenic, heavily used public trail that accesses the Mavericks Beach at Pillar Point Harbor on Half Moon Bay. Bird watchers, dog walkers, school groups and other visitors to the beach and tide pools and Pillar Point Marsh all enjoy the unpaved but wheelchair-accessible trail. The trail also provides access for emergency vehicles. But the trail needs repair from erosion caused by tides, wind waves, and rainwater runoff from the steep Pillar Point

peninsula.

The Harbor District is an independent special district created to build, operate, and maintain harbors in the County. The District maintains the Mavericks Beach trail under agreement with the U.S. Air Force among its many responsibilities at Pillar Point, as the trail crosses both District and Air Force property.

Improvements will come in two phases: a first phase "quick fix" to repair erosion of the trail edge at one location caused largely by runoff from the slope; and a second phase which will include ADAcompliant but still unpaved trail surfacing

improvement, trail edge stabilization, installation of a new ADA-compliant restroom to replace the present portable toilets, and new environmentally sensitive vehicle parking lot surfacing that avoids pavement.

This year's budget includes approximately \$365,000 for the whole project based on preliminary engineering estimates. The District will also seek grant funding for the trail and restroom from two state agencies, the Coastal Conservancy and Wildlife Conservation Board.

The District has begun the permit process with the Coastal Commission. It will also seek approvals from the State Lands Commission, Army Corps of Engineers, Regional Water Quality Control Board and San Mateo County.

Because of the considerable public interest in and use of the trail, the District will convene periodic public update meetings to inform the public on project progress and obtain citizen input, and maintain updates on the District's website.

This report is the second in a series of public informational pieces designed to keep the public informed of the Harbor District's many productive activities. (See Clean Marinas on the District's website: www.smharbor.com.) Stay tuned for more to come.
