Community Celebration For Our Veterans

The community is invited to join with many others to celebrate Veterans Day, starting with Veterans Day on November 11, and an evening of activities on Saturday November 16 at the Foster City Rec Center, continuously with a Program at 6PM, a prime rib buffet at 7PM, and raffles and activities throughout the evening.

Good Bye & Hello

At the first City Council meeting in December each year, the City reinvents itself when we say goodbye to leaving Councilmembers, swear in new Councilmembers and elect a new Mayor and Vice Mayor. On the surface it seems straight forward and a bit mundane. But here's the rest of the story.

This year on December 2nd, we must say goodbye to one of the most beloved city servants in Foster City's history. Mayor Pam Frisella will end her eight-year tenure on the City Council and return to her private life as a citizen and, in her words, the best role as Grandma to her beautiful grandchildren.

Before her days as a Councilmember, Pam served on the Parks and Recreation Committee where she was instrumental in creating the finest baseball/soccer complex on the Peninsula, Sea Cloud Park. Pam was a Little League baseball manager then and her teams had to endure the wind and dust at the former fields next to City Hall. She was thrilled when she went before the City Council and convinced them to build Sea Cloud Park and was involved in the design of the baseball fields for the Little Leaguers and the Youth Baseball age kids.

Pam began her term as a Councilmember in December 2005. She has been a most competent and prepared Councilmember, easily grasping the most complex and tedious agenda items and running an efficient and successful Council meeting as the Mayor. Not only was she a key figure here in Foster City but she also represented Foster City in the County community. She chaired and was a member of many committees that were regional in nature and handled important issues like regional housing (HEART), solid



waste (SBWMA), and library services. She has also continued her volunteer service with Samaritan House and the San Mateo Police Activities League. Everyone loved working with Pam.

Three words describe Pam to a "T": Colorful, Loveable and Irreverent. If you know Pam then you know these descriptive adjectives are a perfect fit.

I will miss her for a variety of reasons, mostly as a trusted friend and colleague. I could count on her to make logical, rational and deliberate decisions that would benefit all residents of this beautiful city. She was a "cornerstone" in which she would consistently listen to residents' concerns and seek solutions that would address those needs. It was her attention to the "moral fabric" of the community

Fire Chief Michael Keefe has announced that the Foster City Fire Department will provide Cardiopulmonary Resuscitation (CPR) Training for Foster City residents on November 16, 2013 from 9 AM to 3 PM at the Fire Station.

The Heartsaver CPR with AED course is a modular class that teaches lay rescuers how to recognize and treat life threatening emergencies, including cardiac arrest and

choking for adult, child and infant victims.

Cardiopulmonary Resuscitation training is offered to Foster City residents age 12 and older for only \$25. Grand Re-Opening Ceremony for the Foster City Levee Pedway

The City of Foster City is pleased to invite the public to a celebration of the Grand Re-Opening of the Foster City Levee Pedway! A ribbon-cutting ceremony will be held on November 20, 2013 at 1:45 PM on the pedway at the end of the concrete pathway that is accessible from the corner of Port Royal Avenue and Cumberland Court.

In 2010 the City undertook to comprehensively repave, repair and reconstruct the 8-mile levee pedway. On October 31, 2013, the final phase of this intensive project was substantially

completed. The work consisted of pavement grinding, base repairs, asphalt repaving and/or seal coating, re-striping of the pedway and installation of a new feature: a 2-foot path adjacent to the pedway on the inboard side for walkers and joggers.

Foster City's levee pedway is a premier recreational amenity as well as a thoroughfare for bicyclists and pedestrians. It serves not only Foster City, but as a segment of the Bay Trail, it follows the bayshore around the edge of the city and

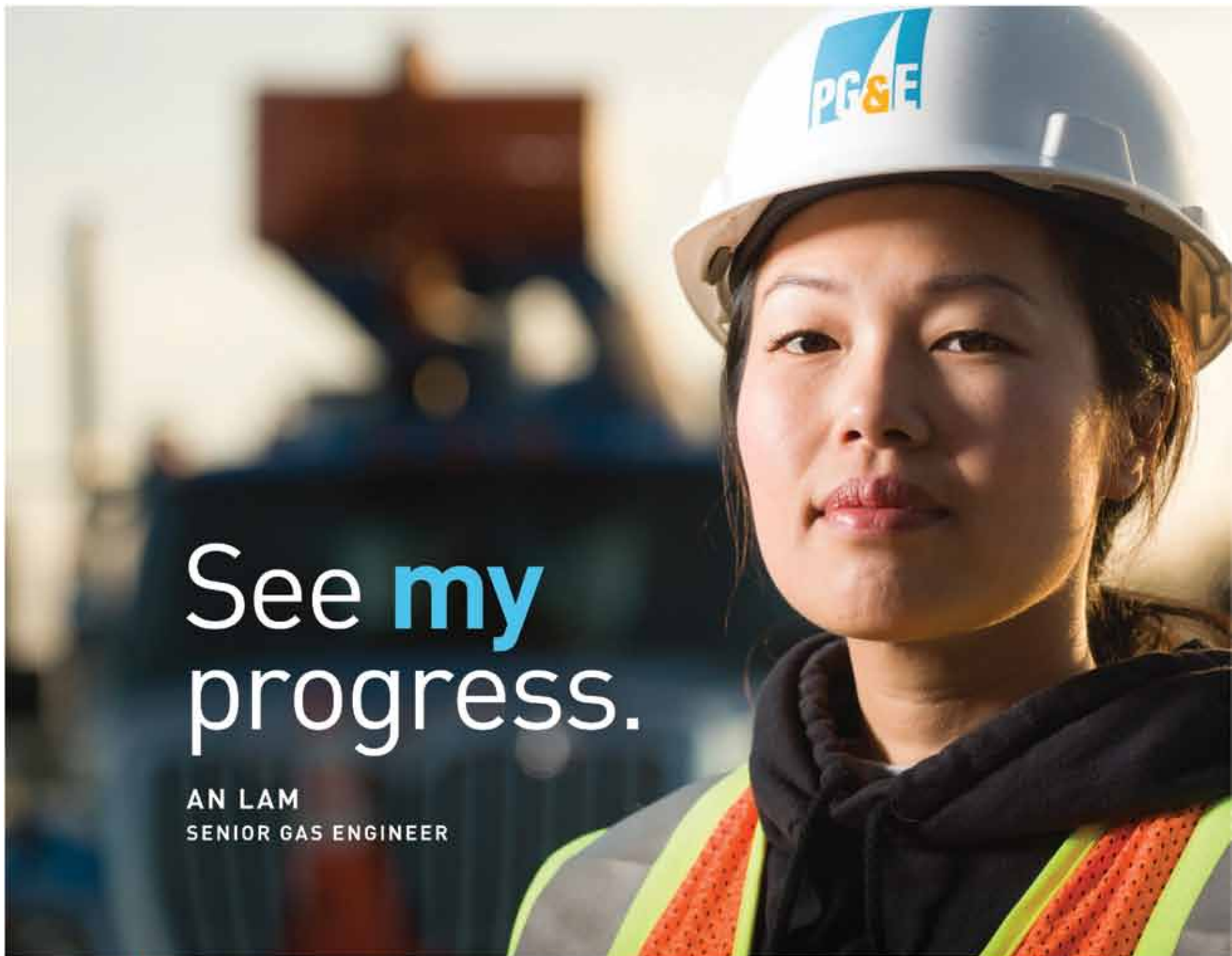

challenge of protecting our country. Within weeks these same people are there to answer this challenge and their lives get changed forever, their danger begins.

Unlike the public, their daily routines are changed drastically. Deployed to a region of the world they never knew to fight someone with harmful intent. Sometimes they live in deployable conditions. Their body showers, dental hygiene and sleep cycles are disrupted. They might spend weeks in damp, cold improvised trenches or fox holes in freezing cold or torrential heat. Thirsty, hungry unable to relieve their body waste when needed; these people stay at their posts. They hear and see things the public never views, yet somehow they endure the wrath of battle. Their stomachs will turn in the anguish of combat and teenage lifestyle might suddenly realize the difference between a "high school hickey" and a "combat hemorrhage". They are forced to make decisions that might change outcomes or possibly destroy lives. They are afraid to

make friends for they could lose them in a short time and history has recorded that many military ranks loss their lives before the age of 25.

The returning war torn veterans finally return home, changed in so many ways. They bring their nightmares home with them and fight to repress their anguish. Then there were those that were POWs combating greater mental battles that they fight every day that the general public knows little about. Veterans are not supermen; they suppress their emotions but hurt inside. The fortunate ones have the strength of their family or friends to reach out to as well as other veterans who have shared their experiences. Some never recover, they lose everything.

As a World War 2 D-Day survivor once quoted to me "I wouldn't give a plug nickel for my experiences, but I wouldn't sell them for a million dollars".

Hell, we might just be veterans, but we did our jobs well. I salute you all!

Upon studying the mural in a tour led by Cultural Arts Director, Kimberly Gordon, and learning of the symbolism captured throughout the mural's 1,560 square feet, Senator Hill said, "This is something that everyone should see. It really grasps you. The more people that see and understand the meaning of justice, the more engaged

What About Those "Other" Boats on the Water? Part two...



Ever wonder why you see boats propelled by gas powered engines on our lagoon, when those engines are prohibited on our waterways? Those would be the boats

owned by our very own Public Works department.

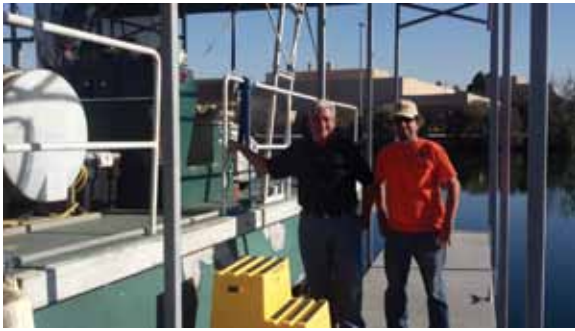
While so many of us enjoy the recreational benefits of our lagoon, it was actually designed and built to act as Foster City's flood control system. And, because it provides such a vital role in keeping our City dry, it's important that it be properly maintained.

I recently had the pleasure of meeting with Nick Leonoudakis, Public Works Maintenance Supervisor and Jon Schmeckle, Lead Maintenance Worker for Streets & Lagoon. They showed me around their "shop" and provided me with interesting stats on the Public Works boats.

The first boat is a 19' Triumph V hull boat with a 60hp outboard motor. The second is a large pontoon boat that measures 25' by 8'. Both boats are removed from the water when they're not in use. The pontoon boat sits in its very own hydraulic boat hoist stationed in the water at the Public Works Corporate Yard on Third Avenue.

The larger pontoon boat is the workhorse of the fleet. It has an 18' spray boom, a 6500 watt generator and a 110 gallon tank that holds the dye used to treat the water. This boat has been in service for many years and both Nick and Jon are looking forward to taking delivery of a new, replacement pontoon boat sometime in 2014.

In order to control the weed and algae growth in the lagoon, Public Works starts dyeing the water the 1st week in April and again the 1st week of May. During the warmer summer months they dye the water about 2 times a week on the perimeters and about once a month in the "tighter" areas (narrower waterways). It takes about 275 gallons of the organic dye to treat the entire lagoon.



The Public Works boats assist periodically in locating and removing submerged objects. They have pulled shopping carts out of the water near Edgewater Shopping Center and most recently located and retrieved a BBQ and propane tank that was hit by an unsuspecting boater. They have also retrieved boats that have gone adrift, and this summer returned a boat dock that came dislodged in a storm to its

In Other Lagoon News...

The Public Works department will be performing their annual lowering of the lagoon levels on or around November 15. The water level will stay down until they raise it again around March 15. The water is typically lowered about 8", but they will lower it even more if we're expecting a large rainfall.

Be sure to check your boat's dock lines to insure they have enough slack. Otherwise, you run the risk of your dock cleats being pulled out or your boat "hanging up". Thanks to dock builder Ted Ross for that helpful information.

Hitching a Ride to "Taste the Magic"

Winter Time is great time to check out new boats and boating technologies. Lithium batteries are now setting the standard for performance in electric powered craft. At the same time, electric motors are becoming smaller and more efficient. Torqeedo, an outboard motor company that brings German Engineering to Electric Boating is a good example of both.

Saturday the Islander caught up with Scott Ruck on the way to the Chamber of Commerce's Taste the Magic event at Edgewater Plaza, where we tested the KONA 15 Electric PowerSkiff. The Kona is a Semi-customized fiberglass boat with flexible seating configurations. It utilizes the larger Torqeedo Cruise (up to 9.9 equivalent horsepower) with 4 AGM maintenance-free batteries below the deck with an on-board charger. Scott described the many accessories available, including canopy, side rails, cocktail table, and console steering.



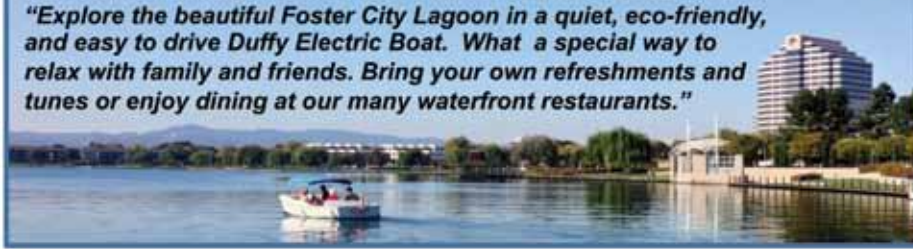

On Friday, October 18th, 2013, Elizabeth Trimble Crosman passed away. She is survived by her four children, Margot Crosman of Alameda, CA, Robert Crosman of Guilford, CT, Darcy Crosman of El Sobrante, CA and Peter Crosman of La Canada, CA; the spouses of her children, David Berks, Betsey Borden, and Deborah Short; her four grandchildren, Miles, Kyle, Katharine, and Maya.

along), the boat clocked 6.5 mph on the GPS. We were gaining slightly on the Duffy when we had to break off as we approached some of the Stanford rowers practicing for Sunday's race.

Scott Ruck, the Torqueedo dealer serving this area, developed an electric Sport-boat capable of pulling a water-skier. That convinced him that electric propulsion made sense for recreational boating. Scott started Ruckmarine in early 2013. In addition to Torqueedo, he chose leading suppliers KONA sport-boats, and TeamScarab Inflatables as industry partners, focusing exclusively on electric boating. Scott, also a competitive sailboat racer, is located in Alameda, and is a frequent visitor in Foster City.

In fact, Sue and Steve at our local California Windsurfing use the smaller Torqueedo Travel model that has an integrated Lithium snap-in battery and goes up to 4 HP on their Dinghy at Leo Ryan Park. "The Torqueedo's power and range means that we spend less time getting to students, and more time helping them, and teaching them" said Steve.

Arriving at Edgewater Plaza, we found most of the dock space taken, and so had to use the Dock's end cap. The long narrow profile of the KONA fit perfectly in the tight space. The docks at Edgewater Plaza are popular for events like this and were completely filled! However as many local boater's will attest, you have to be careful to avoid damage from the docks as they are in severe disrepair in places. Luckily, Scott's boat had ¾ length permanent fenders installed which protected us perfectly. The dock provided the closest parking to the free food and music!

The Taste the Magic event was a great place to be Saturday, with some amazing free food served by the local Merchants. With both Olive's and Waterfront serving, Edgewater is becoming a center for Middle Eastern cuisine. Foster City Residents Sal Cesoprano's booming vocals and Herb Perez' guitar work backed by Eddie Sena, Paul Lynch and JD Smith attracted a crowd as their very professional band Classic Vinyl performed. Popular Edgewater UPS Store owner Jose San Gabriel sat in to sing one of the songs, just for fun (Jose's store by the way has a 4.5 of 5 Yelp score).

Scott Ruck was kind enough to take some new friends on a cruise around the Lagoon. As the 4 adults and two kids motored away I noticed thin, flexible solar panels installed on the top of his bimini top. When he returned, he explained that the panels provide enough power to cruise at about 2 miles per hour without running the battery down. They are intended to extend cruising range and to recharge the batteries when the boat is stopped. If you only use your boat once or twice a week, you probably never need to plug it in. The boat does have an integrated charger.

The Kona 15 is often procured with a trailer. It can be pulled with any just about any SUV and many cars, so you can keep it at Foster City but take it to other lakes and reservoirs in the area for exploring, fishing, and camping. These smaller boats can be kept out of the water, or easily pulled out for periodic cleaning so bottom paint is not necessary. You can remove the electric outboard and replace it with a gas

outboard if you want to use it to cover longer distances on the Bay, the Delta or large lakes.

I was impressed by the boat, and asked Scott what they went for. Ruckmarine offers a complete package for less than \$14,000. The variety of options, and accessories available are too numerous to mention here. Scott works with customers to put together a package that best meets their needs in terms of power options, steering and control consoles, seating configurations, and accessories. There are some great photos of the KONA, and the inflatable SCARIB at Ruckmarine.com.

Our evening ended with a very friendly discussion on the dock with Michael Turner of Edgewater Marine about local boating and Michael's new Duffy Rental Program. Michael had his flagship Duffy docked next to us, and offered some of his Lagoon experience and expertise. Michael also shared his very humorous battle to protect his lawn from Coots (birds that

eat your grass to nothing). Scott told of his vengeance toward Raccoons, another enemy of a well manicured lawn. As day turned into night it was getting cold
